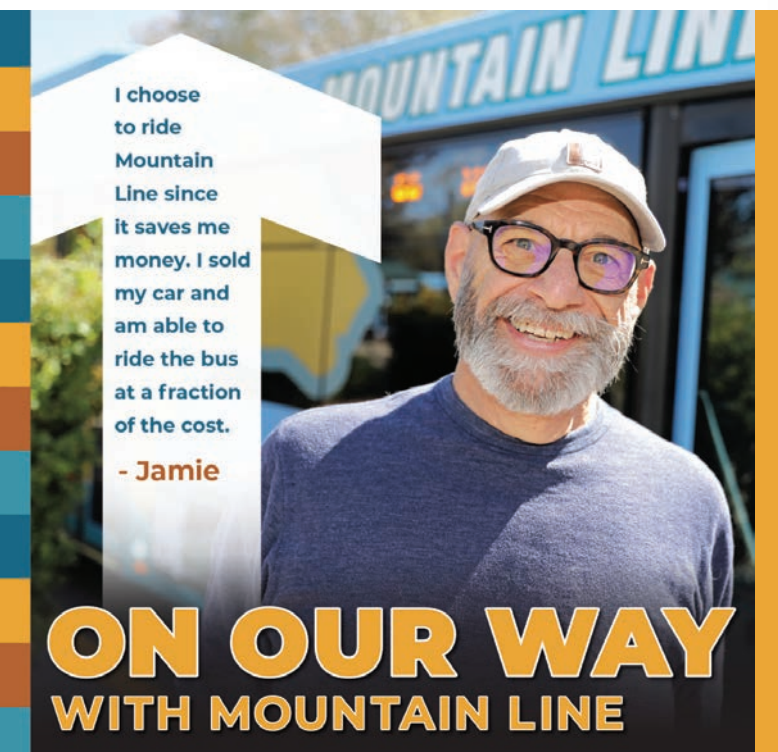

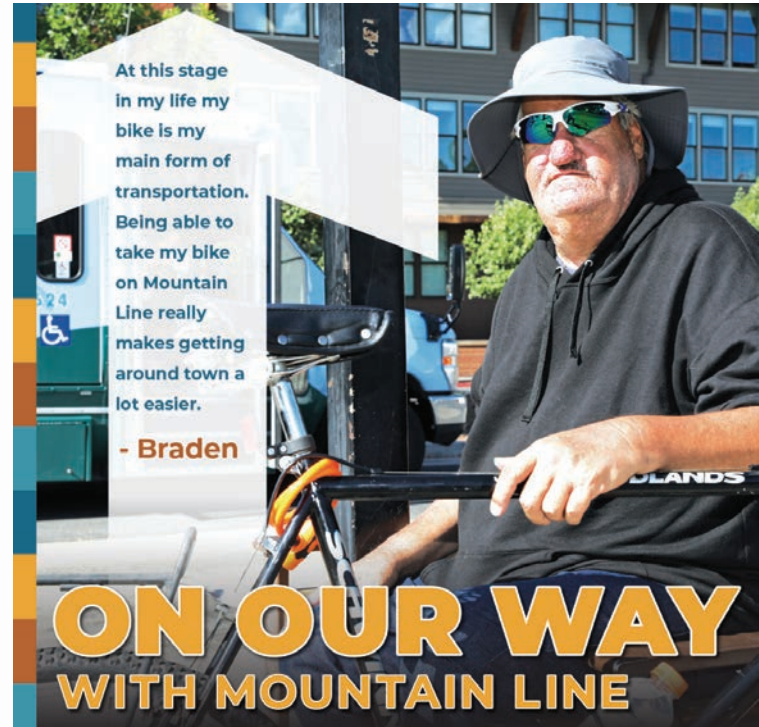

#### Transit Delivered! Valley Metro | City of Phoenix Northwest Extension Phase II (Doyle)

On January 27, 2024, the Northwest Extension Phase II light rail project opened for service. The opening of the 1.6-mile extension expands the Valley Metro Rail system to 30 miles, while opening new connections to the West Valley. Residents can now travel from Mesa, Tempe, and downtown Phoenix to new areas of northwest Phoenix.

The project adds three new light rail stations and includes a series of "firsts" for Valley Metro and the community, including the first elevated station, a rail-only bridge over I-17, a four-story parking garage, and a multi-modal transit center named after regional transit champion, former Phoenix Mayor, and Councilmember Thelda Williams. The extension is expected to service 1,400 new daily riders. Completed over a year ahead of the grant revenue service date and \$30M+ under budget, the project and its leadership team have been recognized locally and nationally with more than 16 different awards to date.

The session is provided for transit system employees who may be responsible for making reasonable suspicion determinations. The Federal Transit Administration (FTA) Drug and Alcohol Testing Program regulations state that an employer must require a covered employee to submit to a drug and/or alcohol test when the employer has reasonable suspicion to believe that the employee has used a prohibited drug or misused alcohol.

The training will focus on the physical, behavioral, speech, and performance indicators of probable drug use and alcohol misuse. Supervisors are trained in the facts, circumstances, physical evidence, physical signs, and symptoms or patterns and/or behaviors that are associated with prohibited drug use or alcohol misuse. The training will include resource materials and real-life scenarios. The training meets the requirements of 49 CFR Part 655.14 for reasonable suspicion training.

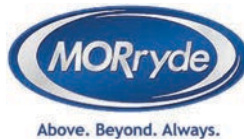
