Route Optimization for Rural Transit Lines

The Central Arizona Regional Transit (CART) system provides intercity bus services between Casa Grande, Coolidge, and Florence 5 days per week and was seeing substantial ridership decline even before COVID, which further impacted ridership. The Route Optimization Study was done as a partnership between the City of Coolidge and the Sun Corridor MPO to identify efficiencies that could be gained to reduce travel times, improve ridership, and reduce resources needed to operate the service. Since the recommendations have been implemented, along with new partnerships to increase the reach of the service, CART has seen a substantial increase in ridership, bringing it back in line with pre-COVID levels.


